This is in response to your June 16, 2015 letter requesting approval for access to Bonneville Dam Count Stations for the purpose making observations of fall Chinook. This is a continuation of a project that has been occurring since 1979. You state you anticipate starting your observations the third week of August and continuing through October 1, 2015. Tule counters would be on-site from about 1000 until 1400 each day.

With respect to the work outlined above, your request is generally approved.
