Dear Chief Operations Manager:

The Umatilla Tribe has implemented a project to restore Pacific lamprey (*Entosphenus tridentatus*) to the tribes' ceded waters. This on-going project is funded by the Bonneville Power Administration and managed by the CTUIR. As part of the project we are requesting permission from the USACOE for access to enter the Bonneville Dam project and collect adult Pacific lamprey.

We will coordinate to utilize fish captured by CRITFC, Tribal, U of I and USACOE staff until our target is obtained. Furthermore, we may explore deploying traps off the face of the dam at areas that are highly coordinated with COE staff and workgroups from May through September, and other collection locations, if feasible. These traps have proven to be very effective at capturing lamprey at John Day and The Dalles dams.

A key component to restoring lampreys to the Umatilla River is to collect adults for translocation to the Umatilla Basin. CTUIR would like to enter the Corp projects to collect up to 4121 adult Pacific lampreys among Bonneville (up to 2060), The Dalles (up to 1056) and John Day (up to 829) dams (in separate letters of access sent to appropriate USACE staff of John Day and The Dalles) and transport to our holding facility. The CTUIR will have all necessary permits for this activity. We will coordinate with Ms. Erin Kovalchuk, Mr. Brian Bissell and Mr. Andrew Derugin at Bonneville Dam, Mr. Jeff Randall at The Dalles Dam, and Mr. Eric Grosvner at John Day Dam. We will continue to coordinate and report our collections with all USACOE staff to ensure a smooth and safe operation, just like in the past recent years. CTUIR has the current versions of "[A Guide For Fish Researchers...](#)" for each appropriate project, and CTUIR will supply all information requested in the Guide prior to work beginning.

We appreciate the cooperation the USACOE has provided to date regarding Pacific lamprey, a culturally important resource of Northwest tribes.
