Dear Ms. Lundell:

This is in response to your January 30, 2018 letter requesting approval for access to The Dalles Lock and Dam in order to conduct a Corps funded research - Lower Columbia River forebay temperature monitoring Phase 1. In 2018, Phase 1 temperature depth profile monitoring will occur near the east fishway exits.

With respect to the work outlined above, your request is generally approved, provided you are able to obtain all necessary documentation. You will need to provide a detailed work statement, project impact statement, job hazard analysis, ESA and state permits, any Material Safety Data Sheets that are applicable and a personnel list noting current First Aid/CPR training. No work may begin until valid and current permits, or an explanation as to why permits are not required, are on file. Please send electronic copies of these documents to Jeff Randall Jeffrey.W.Randall@usace.army.mil and Erin Kovalchuk Erin.H.Kovalchuk@usace.army.mil. You will be required to comply with all reporting requirements found in the current FPP section TDA 3.3.3. Prior to beginning work, please arrange a meeting with Jeff Randall, 541-298-7405.

There are many researchers and contractors working in the area. Please remain in contact with Jeff Randall throughout your time at the dam in order to ensure good communication and cooperation between other agencies and organizations.
