Dear Mr. Barr:

This is in response to your February 28, 2019 letter requesting approval for access to the Boat Restricted Zone (BRZ) at Bonneville Lock and Dam to facilitate the capture and tagging of Northern Pikeminnow as part of the Northern Pikeminnow Management Program. Your forebay work will be conducted the week of 8-12 April and tailrace work the week of 22-26 April.

With respect to your request to access the BRZ, access to the Powerhouse I and II forebay and tailrace BRZ during nighttime hours is approved. Please note that access to both the forebay and tailrace BRZ of the spillway during spill season (April 10 – August 31) is **not** permitted. You will be required to follow the protocols set forth in the Project BRZ guide and must have a valid BRZ permit .

With respect to the objectives outlined above, your request is approved, though please note that Project assistance may be limited, depending on the activities already scheduled at the dam.

Prior to beginning work, please arrange a meeting with Mr. Andrew Derugin, 541-374-4020. No work may begin until copies of all required permits are on file with Mr. Andrew Derugin, Andrew.g.Derugin@usace.army.mil and Mrs. Erin Kovalchuk, Erin.H.Kovalchuk@usace.army.mil .

Please remain in contact with Mr. Derugin throughout your time at the dam. There are many researchers and contractors working at the dam, please work to ensure good communication and cooperation between agencies and organizations.
